**Terms and Conditions of Sale**

Photographic and digital imaging services provided to the Purchaser by Color & Ink Studio Ltd. (the "Seller"), a Michigan corporation, for the reproduction of artwork (the "Artwork") are subject to the following terms and conditions of sale. Any changes or exceptions to these terms and conditions must be in writing and accepted by Seller at the time Purchaser places an order.

1. **Reproduction of Copyrighted Materials.** Purchaser represents and warrants to Seller that Purchaser either: created the Artwork or otherwise owns the copyright for the Artwork; is acting as an agent of the copyright owner; has obtained permission from the copyright owner to reproduce the Artwork; or will use the reproduction of the Artwork solely for teaching, research, criticism, comment, or archival purposes, and will not use the reproduction for any commercial purposes, including sale.
2. **Indemnification.** Purchaser agrees to hold harmless and to indemnify Seller against all costs, expenses, or judgments, including reasonable attorney's fees, arising from any claim or lawsuit against Seller for copyright infringement or other claims or lawsuits relating to reproduction of the Artwork by Seller.
3. **Damages.** Seller shall not be liable for any consequential, incidental, or other damages arising from or relating to reproduction of the Artwork by Seller, regardless of whether such damages were caused by intentional or negligent acts or omissions of Seller or a third party.
4. **Limitation of Liability.** Purchaser acknowledges that reproduction of the Artwork is subject to many factors affecting the appearance and accuracy of the reproduction. Seller will use commercially reasonable efforts to reproduce the Artwork in a timely manner to Purchaser's satisfaction. Seller's liability is limited to any amounts Purchaser has paid to Seller for reproduction of the Artwork. Seller provides no other warranties or indemnities.
5. **Reasonable Care.** Seller will use reasonable care in handling and safeguarding the Artwork while in Seller's possession, but Purchaser acknowledges the risk of damage to the Artwork while being handled or stored. Seller shall not be liable for any damages to or loss of the Artwork, even if due to negligence or other fault of Seller or a third party.
6. **Limited License to Purchaser.** Seller grants to Purchaser a perpetual, royalty-free license to use the reproduction of the Artwork for publicizing or promoting Purchaser's artwork. Such uses include show entries, promotional postcards and advertisements, publications, and web sites. Purchaser may grant permission or sublicense the reproduction to a third party for such use only on a royalty-free basis. All other commercial uses of the reproduction by Purchaser or a third party, including (but not limited to) fine art prints and other items for sale, require a separate license from Seller.
7. **Photographic Credit.** Purchaser agrees to identify and give photographic credit in a form acceptable to Seller when the reproduction of the Artwork is used by Purchaser for publicity or other promotional purposes. Purchaser shall request that third parties using the image also identify and give photographic credit.
8. **Limited License to Seller.** Purchaser grants to Seller a perpetual, royalty-free license to use the reproduction of the Artwork for publicizing or promoting Seller's services. Seller will identify and give appropriate credit to the artist. No other use by Seller is permitted without Purchaser's permission.
9. **Cancellation Charges.** If an order is cancelled prior to delivery, Purchaser is responsible for and shall pay all costs incurred by Seller prior to cancellation.
10. **Collection Charges.** A 1.5% monthly service charge is payable on all overdue balances, and a \$30 charge will be made for returned checks. Purchaser is responsible for any legal fees necessitated by default in payment.
11. **Acceptance of Terms.** An order placed with Seller for reproduction of the Artwork shall constitute acceptance of these terms by Purchaser.
